### Payment

At the first session, you and your therapist will confirm your session fee amount, and whether to access scholarship funds according to the policy described below. Thereafter, the full fee amount (or your portion of the full fee) will be due at the beginning of each session. Having your payment ready will allow more time to work during your session. Fees not paid after thirty days are subject to a late fee of \$10.00 per month. Clients with two or more unpaid sessions will not be permitted to schedule additional sessions until the account balance is paid. Payments returned insufficient funds will be subject to a fee of \$20 per NSF occurrence.

### Cancellations

Your appointment time is reserved for you. In order to cancel without charge, 24-hour notice is **required**. Cancellations for Monday appointments should be left on the counselor's voicemail at least 24 hours in advance. Appointments canceled for reasons other than emergency or illness will be charged the agreed fee.

### Scholarships

Our goal is to serve the community with affordable Christian counseling services regardless of ability to pay. While we do not discount our fees, we have scholarship funds available based on client need. Our scholarship policy is as follows:

1. Clients requesting scholarship funds must demonstrate financial need.
2. Scholarship recipients must contribute a minimum of: \$35 per session.
3. Scholarship funds are available to pay for: Up to 12 sessions per client /Up to \$420 per client.
4. When scholarship award is pending, clients are required to pay the full session fees.
5. Our annual scholarship fund limit is \$16,500.
